Unsure about the new tax law? Save on taxes when you give from your IRA

If you are age 70 and 1/2 and have an IRA, you might want to think about using your IRA for charitable giving this year.

You can make required minimum distributions directly from your IRA to charity, tax-free. This effectively lowers your adjusted gross income. This benefits those who will no longer itemize, but gives a similar benefit to a deduction.

This is a great way to support a scholarship for one of our local students. With a \$1,000 distribution from your IRA, you can create a named scholarship that will go out in 2019.

The Emergency Financial Assistance Program will assist Grove area residents who need help with evictions, cut-off of vital utilities, prescription medications, gas vouchers and bus tickets.

Purchase of two Ophthalmoscope/otoscope sets to be used in patient examination rooms.

***One Child Center for Autism**

Focus Area: Children & Young Adults

For the Applied Behavior Analysis (ABA) Program, an evidence-based behavioral therapy intervention.

Rx Drug Access Partnership

Focus Area: Health & Community Wellness

Grant will support expansion of the “Access to Medication Program” and will increase access to generic medication for 400 uninsured Williamsburg residents.

Virginia Regional Ballet

Focus Area: Arts & Culture

Grant will allow Virginia Regional Ballet to add a dance class for individuals with special needs (ages 5-adult).

Bill Massey Honored for Outstanding Service to Seniors

This past spring, **Williamsburg Landing** presented the Outstanding Service to Seniors Award to **Bill Massey, CEO of Peninsula Agency on Aging**. Williamsburg Landing partnered with WCF to establish a fund to annually honor leaders in the field such as Bill during Older Americans Month each May. A grant was awarded to Peninsula Agency on Aging in Bill's honor by Williamsburg Landing.

"It is hard to estimate the impact that Bill has had on the community, as he is always more focused on seniors and their needs rather than his own role," said **Rick Jackson**, who nominated Bill for the award.

"He is a great collaborator and convener of champions for Seniors. When something needs to be done for seniors in our community, Bill's name is often the first that comes up as a resource or a guide, and he is quick to respond," said Jackson. "Bill does not speak to why things can't be done, but finds ways to get them done."

In addition to his work at Peninsula Agency on Aging, Bill was actively involved in starting the Center for Excellence in Aging. He worked with the local Senior Services Coalition to develop the Community Action Plan on Aging, and later helped bring a branch of Peninsula Agency on Aging to Williamsburg.

"Because of his quiet way of working behind the scenes, Bill is not often specifically recognized for his contributions. This is a great opportunity to celebrate all that he has done."
