Economic Mobility Fund

In 2022, Dian Calderone established the Economic Mobility Scholarship Fund. "The purpose of these funds is to target non-traditional, underserved individuals who are unable to access funding for education and training that will assist them in becoming financially stable." said Dian. There are multiple avenues to pursue these credentials but all come at a cost. Local community colleges and healthcare systems often focus their scholarship giving on students coming out of high school, making it harder for individuals who have had a delayed start on a profession for a variety of reasons. This fund — which anyone can contribute to — will help to pay for a variety of educational costs, such as commercial driver's license test fees, certificate programs for X-ray technicians, medical billing training, and special trade contractor training, to name a few.

Sutton Family Scholarship Fund

The Sutton Family Scholarship Fund was established in 2022 by Leanne and Doug Sutton. This endowment is designed to support a student who has advocated for social equity, equality, and acceptance among their peers, is the first in their family to attend college, and has financial need.

"All four of the Sutton kids graduated from Williamsburg schools, namely Jamestown High School and Walsingham Academy. When scholarships were being awarded during that period of time it seemed to us that many of the recipients had strong support systems, allowing them to excel in the classroom." said Leanne. "These same recipients many times also already had the means to attend college. We would like to help a student who would benefit from financial support, who shows ability in the classroom, but as importantly shows promise as a leader in their community."

Bacon Street Youth and Family Services

The Bridges Project, established by Bacon Street Youth and Family Services, began as a desire to meet the needs of youth who might not excel in a "traditional" classroom environment and struggle as they transition from middle school to high school. It is now offered at all 3 WJCC high schools. The program includes Jumpstart, a week-long wilderness/adventure summer program that introduces new mentees to their mentors and Bacon Street staff, and bi-weekly peer-to-peer mentoring during the school year.

Wrapping up each school year, mentors and mentees are honored and acknowledged for their efforts, perseverance, growth, and contributions to the program. Mentees are given the opportunity to "Bridge Up" and return as future mentors so they may pass along skills they have achieved to future mentees.

Because of the Bridges Project, academic achievement has increased and truancy rates have decreased. Students report feeling more closely connected to their school peers, and that the program has helped them build better relationships at home and in the community. As one participant put it: "In a positive way, it's brought me out of my shell to socialize with people."

Community of Faith Mission

Community of Faith Mission (COFM) provides emergency shelter to area residents during the coldest months of the year. These residents are normally sheltered at 18 different host sites over a period of 18 weeks. "Williamsburg Community Foundation has been a tremendous asset for Community of Faith Mission," said Donnie McDaniel, Executive Director of COFM. "Along with grant awards for supplies, WCF's grant award was also instrumental in allowing COFM to provide our full 18 weeks of shelter by providing medical screening personnel and hotel stays while our traditional church sites were still unable to partner with us due to the pandemic."

"COFM is truly grateful for the generosity of Williamsburg Community Foundation." said Donnie. These hotel stays allowed the guests to experience hospitality and security while COFM helped them determine the next step toward moving away from homelessness. COFM welcomes anyone who finds themselves without shelter and serves men, women, and children ranging in age from 1 to 77 years old. In addition to shelter and food, COFM provides toiletries and personal hygiene items, and brings in outside agencies to assist guests in a variety of ways such as finding job training and affordable housing.



COFM is a success due, in part, to the thousands of volunteer hours that are logged in each session.

Each night of service involves a minimum of 21 dedicated volunteers.



John was tireless in helping to raise hundreds of thousands of dollars in support of local women and families stricken by the disease that broke his heart. The Run/Walk continues to this day, inspiring hope, as does the memory of John and Karene O'Hare.
